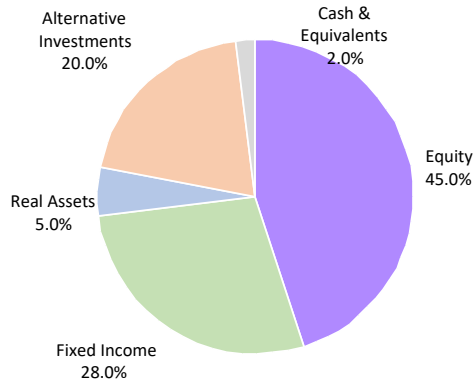

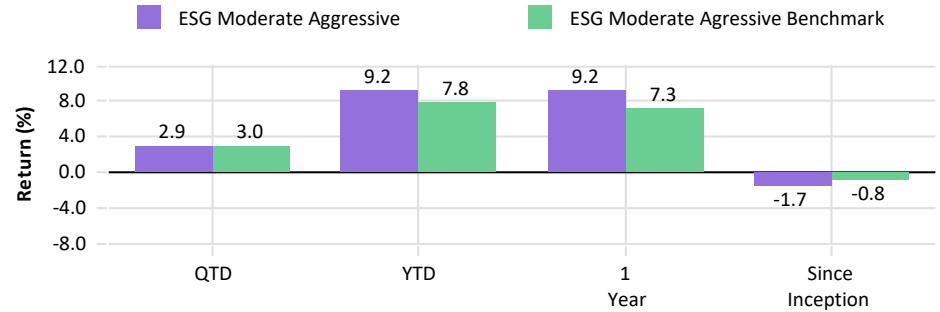

Multi-Period Performance Analysis

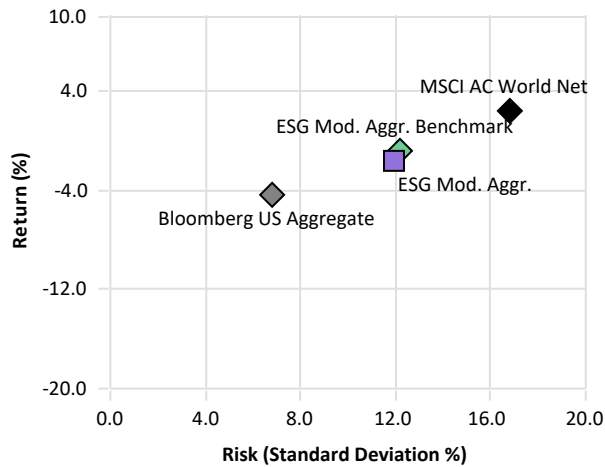
