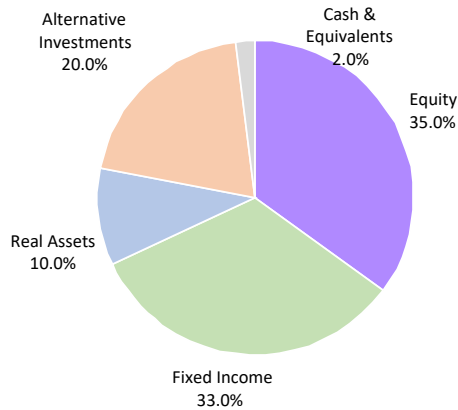

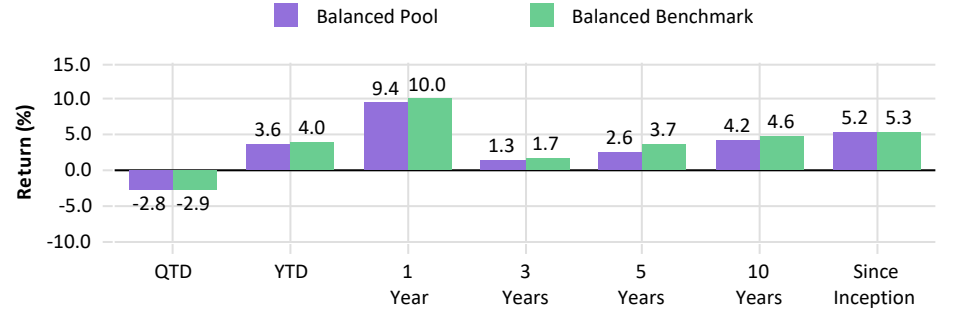
The Balanced Benchmark consists of 35% MSCI ACWI Net, 33% Bloomberg US Aggregate, 7.5% MSCI ACWI Infrastructure, 2.5% Barclays CTA, 20% HFRI Equity Hedge, and 2% FTSE Treasury 3-Month T-bill.

Target Asset Allocation

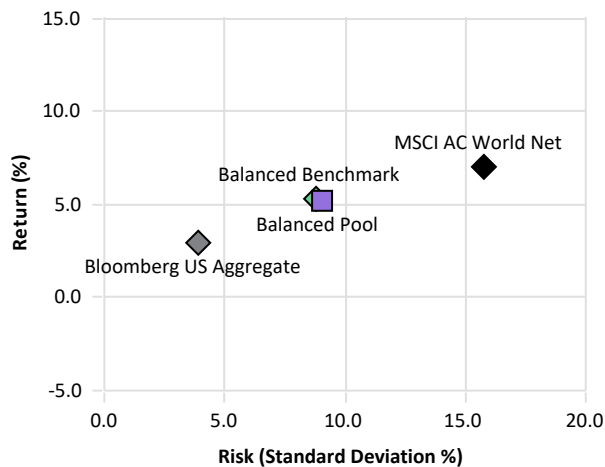
