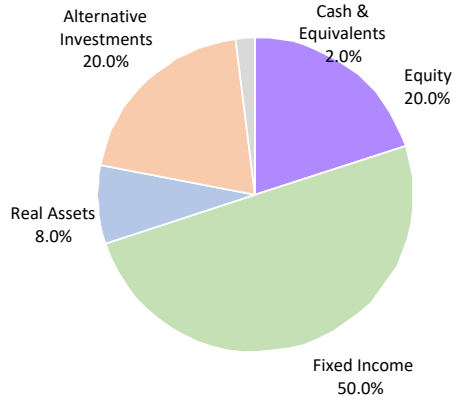

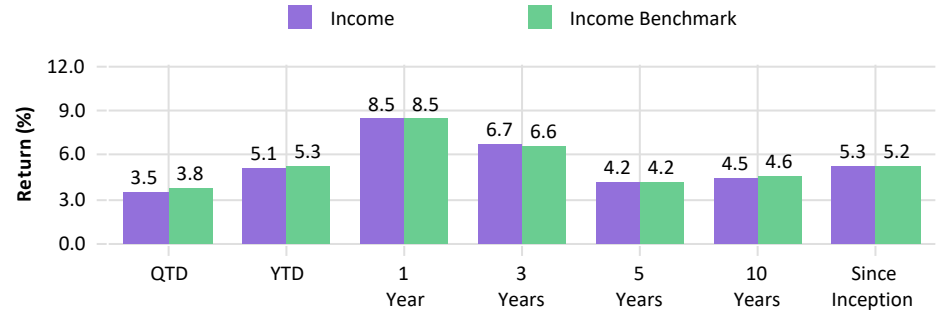

Target Asset Allocation

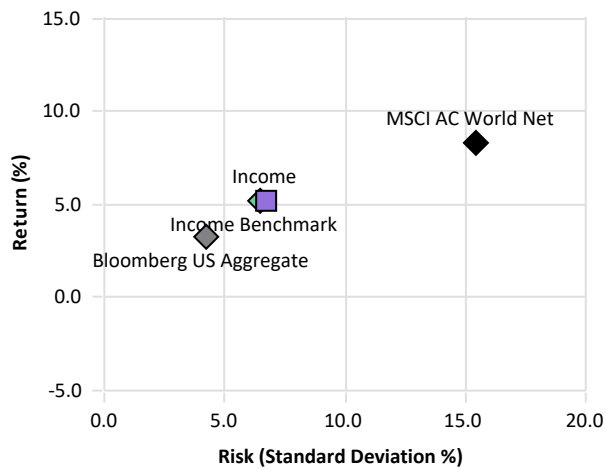
